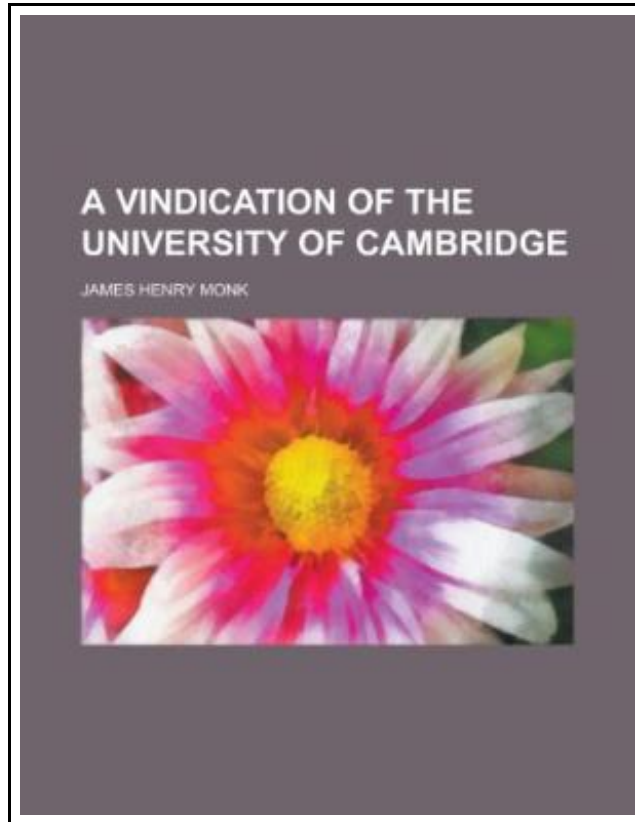

The federal banking Enforcement regulators, SEC, and CFTC also use their independent authorities to examine entities under their supervision for compliance with applicable Authorities 14 BSA AML requirements and regulations. FinCEN has retained 15 enforcement authority and may impose civil penalties for violations. In addition, each of the federal bank regulators also may impose civil money penalties for significant BSA violations, and have specific authority to initiate cease and desist proceedings against the entities they supervise for 12 Pub.
